OWNERSHIP: Proof of ownership must be presented including split papers; sidwell/manatron property number, legal description, registered survey and size of parcel; warranty deed and/or registered land contract. If property owner is not applying for building permit, an affidavit authorizing said agent to make application is necessary.

<u>BUILDING PLANS</u>: Two sets of plans drawn to scale, including wall detail, insulation detail, floor plan, roof section; type of material used, foundation details and other technical data and energy analysis as called for in Section 1301.1.1 of the Michigan Building Code.

<u>PLOT PLAN</u>: The following information must appear on the plot plan drawing:

- 1. Lot dimensions
- 2. Property description
- 3. Address
- 4. House size and location (including driveway, sidewalk, etc.)
- 5. Easements
- 6. Setbacks
- 7. Existing and proposed utilities
- 8. Adjacent house grades and lot grades
- 9. Existing and proposed site grades
- 10. Street name, right-of-way, and road grades
- 11. Septic field location and grade
- 12. Well location
- 13. Proposed drainage patterns (arrows) and downspouts
- 14. Sump pump discharge pipe
- 15. Benchmark
- 16. North arrow
- 17. Drawing scale 1" =30', 1" =20' or 1" =10'

A LICENSED LAND SURVEYOR OR PROFESSIONAL ENGINEER MUST PREPARE PLOT PLANS.

BUILDER INFORMATION: Copy of valid builder's license. A copy of workman's compensation and liability insurance must be provided.

ALL BULDIING PLANS SHALL COMPLY WITH THE CURRENT MICHIGAN BUILDING CODES.

FINANCIAL GUARANTEES AND PERMIT FEES: Shall accompany all permits. The Imlay Township Board shall set these fees.

1. Building official/Department has discretion to lower permit fees and Inspector Bond on smaller projects.

DEMOLITION

VIOLATIONS

Stop work order fee \$125.00 Starting without a permit, fee \$100 to \$500 based on size of project.

RE-INSPECTIONS AND ADDITIONAL INSPECTIONS

Per inspection required \$75.00 or \$85.00 as required A \$75.00 or \$85.00 fee is to be paid prior to re-inspection or taken out of the bond. A reinspection fee will be charged if an inspection is rejected for any reason.

** Note: Any permit issued shall become invalid if the authorized work is not commenced within six months after the issuance of the permit, or if the authorized work is suspended or abandoned for a period of six months after the time of commencing work. A 1-time renewal fee of one half of the original will be charged. A new application and permit shall be required. The performance bond will be forfeited on any permit that becomes invalid. The performance bond is for the benefit of the Township to ensure all fees are paid.

TEMPORARY OCCUPANCY PERMITS

May be issued for 30 days at a time, not to exceed a period of 90 days. A cash bond may be required in some instances. Fees may be adjusted at the discretion of the building inspector. Bond to be refunded 30 days after all codes are met and a final occupancy permit is issued. **BUILDING INSPECTIONS REQUIRED:**
